# Missouri in Motion

AAUW members answered the call for change at the 2007 Convention in Phoenix, June 29-July 2. Like a mythical phoenix rising anew, the organization's national structure will look different, but its heart will be the same.

What will AAUW look like? In brief, in 2009 the boards of AAUW and the Educational Foundation (EF) will be merged into a single smaller board for efficiency. The financial assets will be combined into a nonprofit, 501(c)(3) corporation. Lobbying on our issues will still be done by this organization. A smaller, 501(c)(4) corporation will handle voter guides. Member voting can now be done by mail and electronically in between conventions, if necessary.

Many financial and structural details will be worked out over the next 2 years by the transitional boards of AAUW and EF. We are fortunate to be represented on the transitional board by Shirley Breeze of Ferguson-Florissant Branch, Regional Director (RD) of the Southwest Central Region, who was selected by fellow RDs to be one of the two RD representatives on the board.

Missouri was recognized on the member, branch, and state level with a remarkable number of awards.

Sue Barley, Ballwin-Chesterfield Branch, was honored as one of 17 Founding Leaders of AAUW. This select group was recognized for their significant financial commitment to the mission and future of AAUW. We are extremely proud of Sue!

The Ballwin-Chesterfield Branch won the national Grand Prize in the Member-Get-A-Member program, bringing in 32 new members! Ballwin-Chesterfield was fifth in the nation in total EF contributions and ninth in total Legal Advocacy Fund (LAF) contributions. Their display on their Dollars for Scholars fundraising projects was selected to be shown in the Taste of Success area. Fantastic achievements, Ballwin-Chesterfield members!

Missouri repeated as a winner of the 21st Century Platinum Award for states, the highest category in this program. In Cumulative Giving (combined Association, Leadership and Train-

ing Institute, EF, and LAF), we were fifth among all states in the contribution growth over the previous year and ninth in per capita; in LAF contributions we were 10th in contribution growth and ninth in per capita giving. Many thanks to Yvonne Morrison, state EF chair; Julie Triplett, outgoing state LAF chair; all branch EF and LAF chairs; and members who provided leadership and generous donations to support these worthy funds.

Grace Butler was elected as an alternate to the Nominating Committee. Jan Scott served on the Convention Resolutions Committee.

Younger women want to be involved in an activity where they feel they are making a difference. Students need to learn about AAUW so they will be more likely to join when eligible, and they need to learn that equity is still an issue.

Board members will continue to serve as liaisons to different branches. I encourage you to invite your branch liaison or a state officer to a branch meeting this year and share your own successes!

## FROM THE SOUTHWEST CENTRAL REGIONAL DIRECTOR

It was a wonderful convention! All the proposed bylaws (with a few minor changes) were approved. We are on our way toward making the Association a more viable, responsive, fiscally stable organization! The major speakers were inspiring; the workshop sessions were very productive. I was privileged to be elected to serve the SWC Region again as RD and also selected to serve as one of two RDs on the Association Board. The Association and Educational Foundation boards met at the end of July to start the process of implementation of the decisions made by the membership. Also, at this meeting, discussions were held on the future of national conventions and regional conferences. At the Regional Caucus in Phoenix, Pat Ross (TX) was elected to serve on the Association Nominating Committee for SWC Region and Grace Butler (MO) was elected as alternate. Michele Wetherald, Executive Director, has indicated that she will leave her position at the end of the year. A search committee has been selected to begin the process of hiring a new person.



Congratulations to Missouri for the awards and recognitions received in Phoenix; Missouri was chosen for the 21st Century Platinum Award. Also, Missouri was in the top 10 states for LAF contributions and top 10 for growth over the previous year. Missouri was recognized in EF funding as being among the top 10 states for increased contributions over the previous year. Ballwin-Chesterfield Branch, also, won several recognitions, including being the top branch in membership recruitment.

As we prepare to start a new AAUW year, there are a number of areas to think about:

### Creve Coeur Branch names new Buella Brooks Scholarship

Creve Coeur Branch of AAUW is privileged to honor our outstanding member and educator with a new scholarship: The Buella Brooks Scholarship.

Her mother was an educator, while her father had a job in the financial accounting section of a Kentucky coal mine. Unfortunately, when "Jim Crow prejudice entered the picture", her father lost this position with the coal mining company. The family later

moved to St. Louis. After graduation from Sumner High School in 1932, Buella continued her education at Stowe Teacher's College and began her 42 year career in Education.

Between 1941 and 1946 (during WW II), Buella served as Program Director of the USO at the Army-Navy YMCA in Columbus, Georgia. When she returned to St. Louis, Buella met and married her soul mate, Lawrence Brooks. She attended Washington University receiving a Masters of Arts in Education.

Buella served as a classroom teacher, reading specialist, supervisory teacher, and principal during her teaching career. As students planned for their future, Buella encouraged them to look into the mirror and be pleased with what they had done with their life so far. She told them to let their conscience be their guide and be strong enough to keep on the right path.

Barbara Lackritz asked Buella to join the Creve Coeur Branch of AAUW in 1980. Buella recalls working on many committees, helping with garage sales, participating in current event discussions, playing in the afternoon bridge group, gift-wrapping at Borders, and enjoying delightful fellowship of the members.

Buella always encourages women to be involved in world events, and this scholarship will perpetuate her goals and dreams into the future as we help young women earn college degrees. --Jayne Kasten

## Missouri AAUW Peg Witt Incentive Grant

This program responds to those yearnings in the form of grants available. Take time to learn more about the grants. Although the grants are small and competitive, each branch is urged to explore the benefits offered.

Branches may apply for one of three grants to:

1. Stimulate growth by organizing new branches, including student affiliates or by strengthening weak branches (up to \$450).
2. Stimulate member interest in participating at all levels, state, regional, and association to raise awareness and share concepts (up to \$225)
3. Stimulate innovative branch project planning (\$550)

Ferguson Florissant Branch received a grant last year for a plan to publicize widely at the community festival while Parkville Branch scored by organizing a student affiliate branch. Several suggestions are listed in the grant cover letter.

Study the applications. Use creative thinking. Develop a plan. Put it in writing. Meet the **October 1, 2008 deadline.**

### RECOGNITION ON THE NATIONAL LEVEL

Missouri had a banner year raising \$42,056.74 in donations for the Educational Foundation. Your generous donations enabled Missouri to place in the top ten nationally in per capita donations and in contribution growth over the previous recognition year. Missouri was:

- 9th place in per capita contributions with \$ 41.26 and
- 7th in contribution growth over the previous recognition year with 39%

The Ballwin-Chesterfield Branch was 5th place in total contributions with \$18,488. – Congratulations to Carol Thomas and Cecelia McFadden branch EF co-chairs for an outstanding job.

The Top Ten Branch and State Fundraising awards are the Foundation's highest branch and state honors. Missouri received these awards due to the on-going support and commitment of all AAUW Missouri members and donors. Thanks to all of you and due to your efforts for the Foundation we can continue to be a leading champion for women and girls.

### 2007 AAUW ACHIEVEMENT AWARD

Mae Jemison was speaker at the EF banquet and recipient of the 2007 AAUW Achievement Award. She has a background in technology, engineering and medical research. Besides her other accomplishments she was the first African American female astronaut and founder of the Dorothy Jemison Foundation for Excellence. As part of the foundation Mae created an annual international science camp for children.

### 2007 ELEANOR ROOSEVELT FUND AWARD

The Ophelia Project – Mary Baird, President and CEO - was the recipient of this award. The Project serves as a catalyst for positive change within schools and communities.

**2007 RECOGNITION AWARD FOR EMERGING SCHOLARS** was presented to Misty Sailors. Misty has demonstrated exemplary teaching, outstanding research, and a commitment to women students.

## BRIDGE BUILDERS

Bridge Builders is the social justice project for AAUW St. Charles Branch. As St. Charles County, like many other parts of America, has become more diverse, the number of hate crimes and bias incidents have increased. In October 2002, members of AAUW and representatives from several diverse groups met to form an organization to promote respect and understanding among all residents and to support victims of hate crimes or bias. Groups that joined with St. Charles AAUW are: St. Charles Amigos, St. Charles NAACP, Interfaith Alliance, Ethical Society and the Spiritual Assembly of the Baha'is of St. Charles.

When a person falls victim to a bias incident or hate crime, a Bridge Builder calls to determine if the person would like a visit from Bridge Builders. If so, members take food and offers of help. Help has included: repainting a wall defaced with slurs, accompanying a victim to a meeting with a school board or police and going with them to court. In 2005 Fox News TV taped a program featuring Bridge Builders after members helped to repaint a black church that had been defaced with racial slurs. Members of Bridge Builders also write letters to express concern and to assure that the show of intolerance is not shared.

Bridge Builders education forums have featured "Stories of Hope," a readers' theatre presentation of real life stories of women who once were incarcerated, "Let's Talk" a panel sharing stories of everyday intolerance, and "It's All about Being Different," a program to increase understanding of people with disabilities. Bridge Builders also sponsored "Remembering Franklin High School" a program honoring educators and alumni of the only local school to serve African American students before 1955.

Each July, Bridge Builders invites the entire community to our annual picnic. Members provide the food; there are games, raffles, children's activities and live music so members of our diverse community can enjoy a chance to become better acquainted. --Barbara Broadfoot
