

AAUW MISSOURI STATE ASSEMBLY MEETING

Saturday, May 1, 2021

Zoom Call 10 a.m.

Welcome: Sue Shineman, President

At 9:35 a.m. President Sue Shineman welcomed everyone to this first-ever conference by Zoom with a brief introduction and thanks to all for supporting the mission of AAUW. Program VP Lynne Roney also welcomed participants as they entered the Zoom room. Chris Nobbe and Linda Berube provided technical assistance to the more than 70 participants. Lynne explained how to use chat, reactions, and polls.

At 10 am Program VP Lynne Roney introduced speaker Jeanie Latz, Director, AAUW. Using PowerPoint slides, Jeanie highlighted 2020 achievements including awarding \$3.6 million in fellowships and grants. Jeanie predicted that state organizations will play a bigger role, the work toward our mission is going to be hard and take many more resources and that tapping into the expertise of our fellows will be key. Jeanie urged everyone to register for the Public Policy webinar next Tuesday, May 4, entitled "Advancing Priorities in the First 100 Days and Beyond." AAUW is going to continue to improve and do more in scholarships as the cost of education increases. Joy Wheeler, CEO of Girl Scouts, predicts that girls will not be attending universities as much as they are now, that the cost of education is outpacing middle class, and girls today are not interested in traditional careers--they want to build and create. Jeanie urged everyone to vote to look forward, to imagine how we take AAUW to the next level, and to use your voice to shape AAUW for the future. Voting closes May 17. She also commented that the AAUW website will be improved to make it possible for members to communicate with each other. The 5-Star program will be revamped to make it more meaningful.

Carol Cowles, Kansas City, asked Jeanie to affiliate with a MO branch (since she lives in Kansas City). Jeanie is affiliated with UMKC and Women's Council. Karen Francis would like to make it easier for colleges to find out about AAUW opportunities for students.

Jeanie wants to get more information from the branches and encouraged members to email her with questions.

Quorum: Linda Berube, Governance/Parliamentarian

There are 15 Missouri branches represented, with a total of 63 voting members. We have a quorum.

The Standing Rules were emailed prior to this meeting and included in registration packets. There was no one opposed to the Standing Rules.

Approval of Agenda: Sue Shineman

The Agenda was emailed prior to this meeting.

MOTION by Linda Berube, seconded by Dixie Younger, that the proposed Agenda be approved for this meeting.

Voting was done using the "Yes" and "No" reaction buttons in Zoom. **CARRIED UNANIMOUSLY.**

Approval of Minutes of 2020 State Assembly: Marsha Koch, Secretary

Minutes of the May 2, 2020, AAUW State Assembly meeting were emailed to participants prior to this meeting.

MOTION by Jan Scott, seconded by Linda Berube, that the minutes of the 2020 AAUW State Assembly be approved.

CARRIED.

Finance Officer Report: Patt Braley

Patt explained the process of involving the entire board to create the budget and presented the AAUW MO State budget for 2021-2022 and financial report (attached at the end of these minutes). Dividends from our stock investments are deposited into the Operating Fund. A complete Annual Report will be available June 30. Expenditures are expected to be pretty much the same as last year's. The budget of \$13,765 is about \$400 more than last year. We are in good financial shape with a total net worth of \$38,442.58. Voting to approve the proposed budget using Zoom's Yes/No tool was unanimous.

Amendment of Bylaws: Linda Berube, Bylaws

Proposed Bylaws changes were described in detail in the winter 2021 *Missouri in Motion*. Linda read each of the proposed amendments and displayed them on the Zoom screen.

Change 1: clarification of the process for fifty-year honorary life membership

Change 2: changes the title of vice president for membership to membership vice president and vice president for program to program vice president

Change 3: to clarify the process for creating standing and special committees

Change 4: to clarify that annual meetings of the membership can be held virtually and that voting can be completed by electronic means and replace "postmark date" with "date of official notice." It also removes references to state meetings as state leadership conferences or state conventions.

See ADDENDUM 5: PROPOSED BYLAWS CHANGES for details.

Since these proposed changes came from the state board, no motion is needed; however, two-thirds approval of members present is required for passage. Voting to approve the proposed Bylaws changes using Zoom's Yes/No tool was unanimous.

AAUW Missouri Proposed Bylaws Changes

Linda Berube, AAUW Missouri Governance and Parliamentarian

The AAUW Missouri board is proposing the following changes to our bylaws to be approved by the membership at our May 2021 meeting.

Change 1 to Article VII, Section II provides clarification of the process for fifty-year honorary life membership adding that application must be made and approved by the association.

Suggested new wording:

Section 2. Membership and Dues. Fifty-Year Honorary Life Member. After a member has paid Association dues for fifty years, application may be made to be named a Fifty-Year Honorary Life Member. Upon AAUW approval of the application, they will be exempt from the payment of state dues.

Change 2 changes the title of vice president for membership to membership vice president and vice president for program to program vice president. This change requires changes in Article X, sections 1 and 4 and Article XII, Section 1 to change to the new title for each of these positions.

Change 3 to Article XIII, Sections 1 and 2 will clarify the process for creating standing and special committees. This change will remove the names of standing committee chairs from the bylaws and resolve conflict between Section 1 and Section 2 of Article XIII. These changes give the board better flexibility in adding or removing standing committees as the need arises or priorities change.

Suggested change

Section 1. Standing Committees Chairs.

The president shall appoint the standing committee chairs identified in the policies of the state. The president may establish additional standing committees and chairs as needed with the consent of the executive committee. They will serve on the Board of Directors as non-voting members of the board.

Section 2. Special Committees and Task Forces. The president may establish special committees as needed with consent of the executive committee. The president may appoint chairs as needed. The committee chairs will serve as non-voting members of the state Board of Directors.

Change 4 to Article XVI, Sections 1 and 4 will clarify that annual meetings of the membership can be held virtually and that voting can be completed by electronic means and replace "postmark date" with "date of official notice." It also removes references to referring to state meetings as state leadership conferences or state conventions.

Suggested change:

ARTICLE XVI. MEETINGS OF THE MEMBERSHIP

Section 1. Annual Meeting. The state shall hold an annual state meeting to conduct the business of the state organization, including but not limited to electing officers, establishing dues, reviewing the budget, amending bylaws, and receiving reports. The meeting may be held in person, by conference call or by video conference. The exact time, format, and place shall be determined by the Board of Directors. In the event a meeting cannot be held due to unforeseen circumstances, a vote on required state business may be taken by electronic means.

Section 4. Voting.

- a. Each voting member of the Affiliate in good standing by the record date, which is one day preceding the date of the official notice of the meeting or vote, will be entitled to one vote.
- b. The quorum shall be five percent (5%) of the members of the Affiliate as set by the AAUW official February 1 count, preceding the meeting or vote.
