AAUW Missouri Public Policy Education and Advocacy

The AAUW MO Public Policy Committee

is into some "good trouble," as John Lewis would say. We are embarking on six initiatives, some new and some with an updated twist. All are aimed at our advocacy work to make "social change" for women and girls and to identify changes needed to make our environment more equitable for women in daily life, their work life, and in their community.

Social change happens in small steps, and the process takes time. Committee initiatives are:

Elimination of the Use Of Salary History in the Hiring Process. To impact wages, get your local organizations to eliminate the use of salary history in the hiring process. Twelve states and 17 cities across the U.S. have succeeded in passing legislative change. Women, by virtue of childbearing/rearing, caring for aging parents, working low wage jobs, and/or working for a non-profit, have a lower starting basis and are at a disadvantage when an employer asks for their current salary. **Contact Carol Cowles.**

Equal Pay Advocates. Pat Shores, committee facilitator, states the focus of the equal pay advocates is shifting from the Missouri state legislature to local city officials concerning the gender pay gap. They will share information in support of equal pay for equal work for the women who work in their cities and to help them understand that AAUW is a trusted source of information about the gender pay gap. Gender Study by employer. One way to get larger employers to determine if they are paying their employees equitable wages is to ask them to do a Gender Study, which calls for an analysis of each job code and each employee in that job code comparing women and men based on experience, education, skills, and value. Disparity exists just by the nature of the hiring process between new workers coming into the workforce and long-time employees whose wages have not moved upward as they should. University economics or research departments can often lend a student to do the research or are willing to contract with an employer to do this. **Contact Alice Kitchen.**

Paid Leave: Research project. Find out which employers in your area provide paid leave of any kind. Record the employers, the number of employees, the type of paid leave plan they offer and the payer source. This research is a starting point for advocating for paid leave from the local employers. The Kansas City League of Women Voters have a program they can provide your branches as a starting point to secure the background on the benefits and challenges to advancing this practice. **Contact Alice Kitchen.**

Voter Education and Advocacy: Several members are active with the Missouri Voter Protection Coalition and at the local level (<u>www.facebook.com/ProtectMissouriVoters</u>). **Contact Karen Francis**

Student Engagement Activity: Reach students through the career development office of their school. Title IX: Review how the local organizations, university, community college, or private college are overseeing Title IX. Are they current on the standards? Who is overseeing the performance standards? How well do students know what Title IX is about and how it affects them? This can be done as a research project, a survey process, or a records review. Star Award/Branch Action Plan Diane Ludwig and Pat Shores

The AAUW MO board made two changes to the State and Branch Action Plans at its October 23 meeting to help clarify two sections of the STAR Award/Branch Action Plan. The first change is in the Education & Research section. The criteria were changed to "achieving 3 of 5" from the original "4 of 5." The second change is to item #40, AAUW Fund, where the statement now reads: "Make a **branch** gift to the Fund in honor of AAUW's 140th anniversary." It is hoped these changes will assist branches in achieving the stated goals and receiving stars.

December is a good time to review the Branch Action Plan and see how the branch is doing. Star award reports will be due on April 1, 2022 covering activities from April 1, 2021, through March 31, 2022.

National AAUW developed the AAUW Strategic Plan 2.0 and the state board wrote Missouri State Board Action Plans this summer for the state to follow and identified Branch Action Plans for the branches to use. Diversity – Equity – Inclusion


DEI Term Awareness; AAUW MO DEI Co-chairs are Kay Meyer and Mabel Davis.

AAUW MO contributed a document for inclusion in the State Historical Society of Missouri's (SHSMO) time capsule, a celebration of Missouri's 200th anniversary. The capsule will be opened in 25 years in 2046. As requested by SHSMO, all entries consisted of three parts: The Past, The Present, and Notes to Future Missourians. The list of nine items in The Notes included projects dear to AAUW, such as ratification of the ERA, Missouri Legislature support of Title IX, and installation of more women in the Hall of Famous Missourians in the State Capitol. AAUW MO received a Certificate of Contribution in appreciation of our contribution.

Panel for the 19TH Amendment 101st Celebration A Success Ellen Irons

The AAUW Missouri panel "Women's Suffrage, Racism and Intersectionality - One year after the 19th Amendment Centennial" was held via Zoom on August 26 with two inspiring speakers: **Dr. April Langley**, associate professor of English and Black Studies at the University of Missouri-Columbia and **Dr. Carmaletta Williams**, executive director of Black Archives of Mid-America in Kansas City.

Moderated by Ellen Irons, the program asked the speakers three essential questions:

Can you share with us your perspectives on black women's historical human rights struggle and suffrage? What are your thoughts on contemporary social justice in the context of black women's history?

How do you define or understand intersectionality?

The speakers' responses and interactions with each other created an inspiring and ever-deepening discussion. Audience questions and answers at the end added another dimension, as the speakers encouraged us all to think about intersectionality in our own lives. The program drew 96 participants from six states with members of over 12 different AAUW branches and over 10 other organizations represented. Feedback was extremely positive.

Pay Equity Pat Shores

AAUW of Missouri is shifting the focus of the Equal Pay Advocates from communicating with Missouri state legislators to meeting with local city officials about the gender pay gap. We are making the change because most members of the Senate and House of Representatives have not been receptive to discussing the gender pay gap nor bringing bills to the floor. Five bills were filed last year, and some were assigned to a committee, but none had a hearing. As the registered AAUW of MO lobbyist, Pat will continue to monitor the equal pay bills in the next session.

AAUW branch members established a personal relationship with local officials in 2020–21 when asked to support proclamations for the 100th anniversary of women getting the votes. We want to build on that relationship with our Equal Pay Advocate meetings. We will share information in support of equal pay for equal work for the women who work in their cities and also help local officials see that AAUW is a trusted source of information about the gender pay gap.

The Ballwin-Chesterfield Branch
